

FUSION RESORT & MARINA – RULES & REGULATIONS

VHF – Monitor 16 / Switch to 72
18 SLIPS – ACCOMODATING Vessels up to 71 FEET
High-Speed WIFI – No Charge

***** Liability Insurance MANDATORY for ANY OVERNIGHT STAY and/or when PLUGGED INTO SHOREPOWER *****
***** ALL VEHICLES (Inc. TRAILERS) MUST BE REGISTERED with Front Desk & Display Parking Permit;**
otherwise, they are subject to tow at owner's expense ***

DOCK AT OWN RISK * MUST HAVE OWN LINES AND BUMPERS * NO COMMERCIAL VESSELS * NO PICK UP / DROP
* OFF – HOTEL & RESTAURANT GUESTS ONLY * NO OPEN ALCOHOL on DOCKS / NO OUTSIDE FOOD or BEVERAGE *
FOOD & BEVERAGES can be purchased TO GO at RESORT during Restaurant Hours * NO OPEN CONTAINERS (Alcohol)
ON DOCKS * ONLY LICENSED SERVICE ANIMALS ARE PERMITTED

- DAILY RESTAURANT DOCKAGE – Slips are free for boaters who visit our restaurant. POOL / RESORT AMENITIES ACCESS reserved for registered hotel guests.
- HOTEL GUEST WITH BOAT
 - \$2.50 per foot per night regardless of size / Electric - \$5.00 - \$25.00 FLAT FEE / Fresh Water – No Charge
- LIVABOARDS
 - 12 days MAX “lived aboard” in ANY 30-day / one-month period
 - NO MORE than 5 DAYS CONSECUTIVE “lived aboard” per vessel at ANY TIME
 - NIGHTLY: \$2.50 per foot / Electric - \$5.00 - \$25.00 FLAT FEE / Fresh Water – No Charge
 - MONTHLY: \$15.00 per foot / Electric - METERED billed separate @ Resort cost / Fresh Water – No Charge
 - FULL ACCESS to ALL RESORT AMENITIES (pool, spa, golf cart beach shuttle, and bikes)
 - Certificate of insurance is required for overnight stays on your vessel
- CAR & TRAILER PARKING
 - MUST be authorized IN ADVANCE
 - VEHICLE \$25 per day
 - TRAILER \$50 per day, located across street -> 245 107TH Avenue (EVENTS at FUSION) building
- Monthly & Seasonal Dockage
 - Contact resort directly for a quote
